This New Year looks very promising. When we get the sewage hooked up and the 1st Div. compartment fixed up we will be ready to move back aboard for our work parties. It sure will be great not having to climb those ladders to get to our sleeping quarters on the Yorktown. We really appreciate Patriots Point letting us sleep aboard the carrier for the past few years. The accommodations were great other than dragging our gear up 3 decks. We were always hoping no heart attacks would occur while we were getting up there!!

All of us are really excited about moving back aboard. Of course there are new rules that we have to follow: We can no longer use the grill. We have to cook using the microwave. Patriots Point has plans for more great renovations to the ship too. They are putting a great "Radar Experience" in CIC. I don't have any of the specifics but I do know it is costing about \$10,000. Ari was thrilled and promised to take care of the model. We lost another Okinawa hero on January 6, 2015. Lee Hunt was in the handling room of MT 53 during the Okinawa attack. Lee always visited us when we were there for a work

party. Lee lived in Charleston. They will be missed by all of us.

JANUARY 2015 MINI- WORK PARTY

We had a fine mini work party January 24-31, 2015. The attendees included John Hudak, Don Watson, Rich McKinney, Dave Harhager, Ken Rohloff, Joe Luque, Sonny Walker and Max Sauss. The main job we had to accomplish during the work party was to get the sewage hooked up to the main sewer line running under the pier. This turned out to be a very big job!

Dave Harhager was the designated clip board holder. He did a great job too! John Hudak created and designed the plans to put in a new tank and grinder pump along with a platform to mount on the pier for the connection of the hose from the ship to the pipe connected to the main sewage line.

Jeff Jacobs, of Patriots Point Foundation, is our local "go to guy" and he contacted Coastal Utilities about doing the hook-up under the pier. They also agreed to mount the platform on the pier. After watching them drill the holes and hammer the bolts into the concrete, we decided it was a great idea to have them do it. They have agreed to do this job for under \$3,000.00. We agreed to do all of the work aboard the ship. This included installing a new tank and grinder pump, rerouting the PVC pipe in first division from the port to the starboard side and installing a valve on the main deck where we can attach the hose to go to the pier platform. This will make it possible for us to move back aboard the Laffey to eat, sleep and shower on our own ship. Those ladders are really getting too steep for us to carry our "seabags" up to our quarters on the carrier!

Our guys really worked hard during that week. John got the hole cut in the deck and a "spill catcher tank" was constructed and put in place to hold the tank. Rich McKinney did a lot of the welding as John came down with a bug for a couple of days.

Watson painted the new catch tank. It is now ready for the new tank.

The new tank was delivered and we man handled it forward to put down below. The big problem was... the flanges were 30" and the doorways and hatches were 26". Hmmmmm.? We ended up lifting the tank up to the 01 level by chain hoist and lowering it back to the main deck forward of the breakwater doorway. Now we had to get it down into 1st Division. We trimmed the flanges so we could wiggle it through the doorway. We removed the ladders and lowered the tank through the hatch in the forward fan room and down into first division 2 decks below. It was a 3 hour job. Richard did most of the line handling, Ken did most of the bull work, Donnie did the trimming and Sonny did a lot of the wiggling.

On Wednesday afternoon we got the call that the platform was ready. On Thursday morning Ken and Sonny drove to Columbia (100 miles) to pick-up the platform in Ken's truck. Richard and Ken installed the valve in the main deck while Hudak and Joe Luque worked hard below finishing up the overflow catch tank and it is now ready for the tank.

On Thursday evening the plumbers arrived and mounted the platform to the pier. We cut the fence and made a hole for the gate. John fabricated the gate and we installed it on Friday. Pat Watters treated us to lunch again this trip. He is General George S. Patton's grandson. He is really a friend of the Laffey!

As everyone knows, this is a very costly endeavor. Jeff Jacobs informed us that the Patriots Point Foundation is going to pay for most of it. These folks are truly friends of the Laffey. Unfortunately, we ran out of time to complete the hook-ups. My thanks go out to the guys who worked their butts off during this mini work party.

Lam extremely proud to be a part of this crew!!

It is necessary for another mini work party to get ready for the main work party in April. We need to get the pipes hooked up below decks and get the tank put into place and the pump hooked up. We should be able to get this done in 5 days.

NEW SURFACE WARFARE STRATEGY

The Navy plans to distribute more weapons and offensive firepower throughout the surface fleet as part of a new strategic approach designed to address a fast-changing global threat environment, senior service leaders said Jan. 13 at the Surface Navy Association National Symposium in Arlington, Va.

"We're going to up-gun as many existing platforms as we can to achieve more total lethality," Vice Adm. Thomas Rowden, commander of Naval Surface Forces, said at the symposium.

Referred to as "distributed lethality," the new strategy is aimed at upgrading existing weapons and adding weapons to a wide array of platforms, including destroyers, cruisers, amphibs, carriers and the Littoral Combat Ship variant called the Small Surface Combatant, Rowden explained.

"The first thing we have to do is look at the weapons that currently exist and see what modifications we can make to those systems to increase our offensive punch," Rowden said at the symposium. "We are looking around the fleet to target lethality upgrades wherever we can."

As part of a discussion of this new strategy, Rowden said the Navy plans to acquire a new, offensive long-range anti-surface weapon that puts U.S. Navy surface forces back on the positive side of the range equation with respect to potential adversaries.

The Navy is already working on developing or acquiring a new offensive long-range weapon for the LCS and the Small Surface Combatant.

However, alongside its efforts to arm the LCS and Small Surface Combatant, the Navy is interested in new offensive weaponry options for destroyers, amphibious ships and other platforms, Rowden explained.

"We need to think about this weapon as something we can back fit throughout the DDG fleet. We'll have between 30 and 33 amphibious ships throughout the life of our current 30-year shipbuilding plan. What's to keep us from equipping these ships with an offensive SUW [surface warfare] weapon?" Rowden asked.

The Navy has been looking at long-range missile options for the LCS for months now. Last September, the Navy test-fired a Norwegian long-range precision strike missile from the deck of the LCS.

The missile tested is called The Kongsberg Naval Strike Missile. It is a long-range precision strike missile currently used on Norwegian Nansen-class frigates and Skjold-Class missile torpedo boats. The missile is also used by the Polish Coastal Missile Division, Navy officials said.

The Navy is also looking at a Raytheon-engineered extended-range variant of the Griffin missile that triples the range of the weapon and adds infrared imaging guidance technology.

The existing Griffin missile, which can be launched from the air, sea or land, uses GPS and laser guidance technology. The new variant now being tested allows infrared technology to work in tandem with laser designation, Raytheon officials explained.

Beyond individual missiles, the new overall strategy is aimed at distributing new, existing and upgraded weaponry across the fleet to hold potential adversaries at risk and give fleet commanders more offensive combat options.

"It is about taking the budget that we have and making everything that floats more lethal," Rear Adm. Peter Fanta, director of the surface warfare division, said at the symposium.

Hi, Sonny,



REPORT RECOMMENDS COMBINING EXCHANGE, COMMISARY SYSTEMS

The commissary and exchange should be combined into a single agency that would sell some products at cost and others at a profit, a panel commissioned by lawmakers recommended.

"The commissary and exchange benefits are valued by many service members, retirees, and their families, and should be maintained," according to a report released Thursday by the Military

Compensation and Retirement Modernization Committee.

"A consolidated resale organization, with combined resources, increased operational flexibility, and better alignment of incentives and policies, would improve the viability and stability of these systems," the panel said in the report.

Currently, the exchange is operated by a trio of private companies across the services. The system receives some tax-payer funding, which primarily pays for shipping costs to overseas and rural locations, and sells goods at a profit. That income is then turned around to help fund Morale, Welfare and Recreation (MWR) programs.

The Defense Commissary Agency (DeCA), on the other hand, receives \$1.3 billion in tax-payer funding to pay for employees, shipping and store operations. The agency sells grocery items at cost plus a 5 percent surcharge, which covers the cost of construction and building and technology upkeep.

Under the proposed plan, the exchange systems and DeCA would combine into one system. Grocery items would still be sold at cost, but stores would be permitted to sell at a profit other items currently carried by exchanges. The system would still receive tax-payer funding and some income would still be filtered to MWR programs.

One of the biggest changes that may be felt as a result of the recommendations would be to commissary employees. Currently those workers are government employees, with pay amounts dictated by Congress and government-funded retirement and healthcare. The report, however, recommends moving those more than 12,000 workers to "non-appropriated funds" employee status.

The commission's report was ordered by Congress in 2012. Commission members and their staff held town hall listening sessions, surveyed service members, accepted comment submissions, and attended a Military.com Spouse Summit while conducting research for their recommendations.


