President's Message

Good day members!

It is with sorrow as well as reluctance that a decision has been made to cancel the April 14 - 21, 2020 work party. Obviously COVID-19 being the main factor, there were other mitigating factors that had a domino effect of COVID-19.

Even though there was one member who held out until yesterday and myself, I want to thank all of the members who would have been there. The line up looked like it was going to be entertaining. Hopefully, we can recreate the same line-up for November's work party (TBD). Gov. Hogan (R) Maryland, just locked down the State, effective 8:00 pm tonight and only essential personnel are permitted out of quarantine, which means Sonny & I could not travel if we wanted to :) Be Safe.

On behalf of the entire association members, the executive board as well as board of director's hope you had a healthy and prosperous first quarter of 2020. It did not start off very well with the tragic loss of 25+ lives in Nashville with the tornado devastation and then now the corona virus.

We conducted a mini work party February 1 - 8, 2020 with nine attendees, well ten, when you count our stepson Peyton "Fish" Warner. Talking about Fish, as reported to me and the website, Fish had his medical evaluation hearing to determine whether he was able to continue his service with the US Navy, and with a congratulatory heart I report that the results were favorable and Fish looks like he will be a "lifer". There was not a lot of work to be done, but a lot of prep, and administrative functions to perform to get ready for the November 2020 work party (exact date to be determined). John Hudak continued working on the "Hudak Project" concentrating on the exit ladder opening to the aft. Boiler room port side. He was assisted by our "water boy", Sonny Walker, who stood fire watch the entire time, as well as John Miller who assisted John in the steel used to fabricate the combing for the opening. Max Saus & Joe Luque were running around continuing to correct & improve the electrical integrity of the ship, especially in the aft. boiler room. Ken McCullough, of course, took care of the tool room (HT shop). Ken brought a lot of tools and material to replenish older equipment. And as usual, Ken watched the inventory of what was borrowed, and if not returned, Ken

would hunt you down like a dog to get it back.

Jim Sehy ran around jumping in to do anything that was asked of him, and at the end of the work party Jim and your president were promoted to sanitation engineers. We scrubbed and cleaned three heads which should be clean for the November work party. I saved the best for last, our vice president Mike Pereira outdid himself yet again in his culinary concoctions. If you went home hungry, that was on you. Good job Mikey. Next time please make sure you make more chicken dishes. That was an inside joke between us and another member 🐵. Again, Mikey was able to continue his wooing with our paint supplier in that the shipment we received from them during the work party was substantial and also gratis.

On February 4, 2020 I finally had a meeting with the executive director of Patriots Point, Larry Murray. VP Mike Pereira, and past president Sonny Walker were also in attendance. The meeting lasted approximately half an hour. I walked away with the impression that Mr. Murray is PRO VOLUNTEER and a friend of the Laffey. That is what we really need right now.

Rumor control is that the Clamagore should be leaving Patriots Point before years end as a reef? The Laffey is scheduled to go up river to dry dock in 2021 for a bottom paint job. Exact date not known at this point, but I am hoping that it would be done between late April and mid-October to prevent any interruption in our work parties. Of course this is predicated upon what the yards have in their scheduling. From what I have seen and been told, the fact that the Laffey does float and when the tide goes out, does rest in mucky waters, this constant movement with the river's bottom causes an abrasive action. That, along with the salinity of the water, is causing the coating to wear much faster than it would if it constantly floated.

There is another concern as to the Laffey's resting place upon its return, so I am going to leave it at that as I do not have any definitive answers at this time, nor do I wish to speculate and cause a slew of rumors to be started.

On February 29th, Sonny and I drove two and a half hours to Cumberland to pay our respect on behalf of the Laffey Association to Robert Knippenburg. We were well accepted by Bob's family upon our arrival. Judy Harhager was there and Sonny found his little place in the corner with Judy to yap yap and catch up on their lives, exchange phone images, etc. Bob will be missed.

VP Pereira was instrumental in obtaining needed parts to be put on display at the Laffey from Battleship Cove, Mass. Some of the items were the D.A.S.H. (Drone Anti-Submarine Helicopter) control box, light off torches for the boiler room, nautical chart parts, etc. They were stored by me for four months until this past work party and transported to the Laffey. Many thanks to Jeff Jacobs and Ken McCullough for arranging the \$1500 Deck Sander "aka" "knuckle buster" donation from the Aurand Manufacturing Company.

On April 16th, 2020, let's all individually honor the 32 sailors who lost their lives in Okinawa on April 16, 1945. A public remembrance ceremony will be scheduled by Patriots Point Naval and Maritime Museum in the near future. Date to be determined.

There will be strict dates that we must adhere to and there will be NO EXCEPTIONS due to the strict contract with the hosting hotel. **There will be a limited room block and a strict cutoff date to** **book by June 1st** so you want to book early.
